# Eclipse Foundation Event Terms and Conditions

1. **Event Management** – The words “Event Management” as used here means Eclipse Foundation AISBL (“Eclipse Foundation”), and any of its committees, agents, suppliers, subcontractor and employees acting for them in the management of the event.
2. **Sponsor Logos** – Sponsor agrees to allowing Eclipse Foundation to use their company logo in our promotional materials for the event, including Eclipse Foundation and conference websites, social media channels, and printed materials, and to use their company logo during the event in acknowledging their sponsorship. Use of Sponsor’s logo will be subject to Sponsor’s then-current logo usage guidelines, which Sponsor must provide in advance. Eclipse Foundation reserves the right to decline to use Sponsor’s logo if it, in its sole discretion, determines it cannot reasonably meet the requirements of the Sponsor’s logo and trademark usage guidelines.
